

CHAPTER 4

## Stakeholder Contributions to Concepts

### 1. Introduction

Community and stakeholder perspectives continue to play an important role in the Hazelwood Rehabilitation Project, as they have since the commencement of the project in 2017.

Following works to decommission and demolish major infrastructure that was once part of the Hazelwood Power Station and Hazelwood Mine, ENGIE Hazelwood has actively engaged with the community and key stakeholders to create a rehabilitation plan focused on safety, stability, sustainability, and future productive land use.

General stakeholder input has been gathered as part of a comprehensive and transparent consultation approach designed to fulfil the requirements of the Project's longer running, bilateral Environmental Effects Statement (EES) and *Environment Protection and Biodiversity Conservation Act 1999* (Cwth) (EPBC) assessment process, which commenced in 2022 and continued up until recently. The Project's EES is expected to go on public exhibition in 2026.

Early, targeted consultation with prescribed stakeholders – directly relating to the development of this DMRP – commenced in May 2024 and is ongoing, with formal consultation planned throughout July and August. This early-stage engagement with prescribed stakeholders has sought to gather feedback specific to:

- proposed rehabilitation approaches;
- potential end land-uses for the rehabilitated site;
- potential risks and liabilities after ENGIE Hazelwood relinquishes the mine licence; and
- expectations for ongoing monitoring and site maintenance.

This Chapter summarises outcomes of this earlystage consultation and outlines how matters raised through these consultations have been considered and responded to as part of the development of the DMRP. It also includes a summary of planned future engagement activities to drive ongoing participation in the DMRP development process.

#### DMRP CONSULTATION REQUIREMENTS

Consultation undertaken to inform the development of ENGIE Hazelwood's DMRP aligns with the Mineral Resources (Sustainable Development) (Mineral Industries) Regulations 2019 (MRSDMI Regulations), section 64G and the Ministerial Guidelines for preparation of Declared Mine Rehabilitation Plans Draft – November 2024

Following the release and exhibition of this Draft DMRP, ENGIE will initiate a formal consultation process to ensure both prescribed stakeholders and the broader public have a genuine opportunity to contribute to and participate in the planning and development of the Hazelwood Rehabilitation Project DMRP. Engagement tactics are outlined in the ENGIE Hazelwood Declared Mine Rehabilitation Plan Stakeholder Engagement Strategy, see Appendix D.

## 2. Consultation Approach

The project has been developed with the belief that proactive, sincere, transparent and respectful consultation is an essential part of successful project development.

Stakeholder consultation on the Hazelwood DMRP has sought to:

- Inform prescribed stakeholders, neighbours, Traditional Owners and local communities about the proposed project, the DMRP process and opportunities for participation.
- Help statutory and non-statutory stakeholders understand the project by providing information about objectives, benefits, principles guiding design and development, and work done to identify, understand and address potential risks.
- Actively encourage prescribed stakeholder participation and seek targeted input during the preparation of the Draft DMRP to obtain specific feedback on measures that respond to identified risks, management controls and potential future land uses.
- Develop a formal process for broader community and stakeholder consultation and submissions on key elements of the DMRP plan.
- Demonstrate how feedback has been considered in the development of the project and the DMRP.

Engagement will continue beyond lodgement of the Project's Draft DMRP. For details of planned future engagement, see the ENGIE Hazelwood Declared Mine Rehabilitation Plan Stakeholder Engagement Strategy, Appendix D. Consultation and community involvement will continue to be a key priority should the project be approved.

## 3. Key Stakeholders

ENGIE Hazelwood has identified individuals, organisations, communities, and groups that it considers should be involved in Project consultation activities based on:

- their potential interest in the Project and its development
- the likelihood that they will be affected by proposed Project activities
- their perceived ability to contribute to Project outcomes.

This includes prescribed stakeholders as specified in the Mineral Resources (Sustainable Development) (Mineral Industries) Regulations 2019 (MRSDMI Regulations), section 64G.

# 6. Amendments to the concept in response to matters raised

Each of these matters has been considered and addressed during the development of the DMRP. Further, ENGIE Hazelwood has sought to utilise material feedback and matters raised through the Technical Reference Group convened as part of the ongoing Hazelwood Rehabilitation Project EES process. This Technical Reference Group is an inter-agency group to advise ENGIE Hazelwood and the Victorian DTP on the scoping and adequacy of EES studies during the preparation of the EES.

Given the EES process and EES technical studies directly focus on the Hazelwood Rehabilitation Project's potential effects on the environment and approaches to manage those effects, this feedback was considered material and useful to inform the development of the DMRP and specific actions and strategies for rehabilitating the Hazelwood mine site.

The following table summarises key matters raised by the Hazelwood Rehabilitation Project Technical Reference Group.
