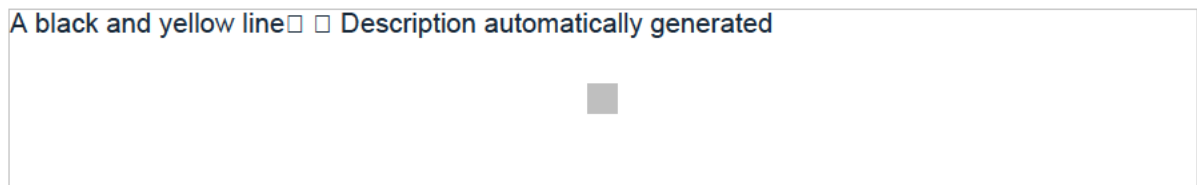

I see an invite has gone in for 22 October for our next meeting. I'll let you know if that doesn't work for anyone on our end but looks good for s47F and I.

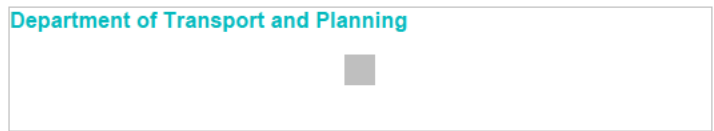
