Cadia Legacy Fund Guidelines



At Newmont Cadia, we distribute funding each year to support and enhance community groups and organisations in the Blayney, Cabonne and Orange Local Government Areas (LGA's). Our Community Partnership Program offers two funding streams, Cadia Cares and the Cadia Legacy Fund.

The **Cadia Legacy Fund** works in partnership with community representatives to develop and deliver strategic projects which will leave a legacy on the local region (within Blayney, Cabonne or Orange LGA's).

Funding

Funding applications of a minimum of \$20,000 and a maximum of \$250,000 will be considered through the Cadia Legacy Fund. Projects must demonstrate strategic alignment with government or key stakeholder plans.

Applications above \$250,000 may be considered for multi-year partnerships. Multiple year partnerships are subject to demonstration of Key Performance Indicator (KPI) achievement.

Eligibility Criteria

- Are within Blayney, Cabonne or Orange LGA's;
- Indiscriminately benefit the whole or a wide section of the local community or will provide a lasting or ongoing benefit to the local community;
- Are one of the following;
 - Incorporated not-for-profit organisations, community group or registered charity;
 - Local, State or Federal Government department;
 - Indigenous identified organisation endorsed by the Orange Local Aboriginal Land Council;
 - Applications from other community, commercial or business structures may be considered on a case by case basis;
- Fits into one or more of the below strategic pillars;
 - Agriculture;
 - Health;
 - Indigenous.
 - Sustainability, Technology & Innovation;
 - Tourism;
- Applicants are only eligible to receive funding once per financial year;
- Projects which have demonstrated support from the local community and align with government or key stakeholders plans (eg. Local councils).
- Projects must be able to demonstrate future financial sustainability

Please note - meeting the eligibility criteria and submitting an application does not guarantee funding.

Cadia Cares Guidelines

Exclusions

Generally, the following will not be considered for the Cadia Legacy Fund:

- · Applications from individuals;
- Applications from political organisations or campaigns;
- Applications from sporting clubs or special interest groups;
- Fundraising events such as dinners, cultural events, or sporting activities;
- · Advertising and marketing materials;
- Applications which have already received funding through the Cadia Cares program;
- Projects which cannot demonstrate community engagement and support from key stakeholders;
- Projects which will not provide long-term objectives to the community;
- · Funding of paid positions.

Application process

Applications for the Cadia Legacy Fund will open twice per year. All interested applicants should discuss their project with a Cadia Social Performance representative prior to completing an application.

Once applications have closed for the round, they will be reviewed by Cadia's Community Partnership Committee.

All applicants will be notified of the outcome of their application.

Funding Obligations

Successful applicants will be required to enter into a partnership agreement and complete an acquittal process. The agreement will cover your obligations regarding;

- Funding committed;
- · Project timelines;
- Publicity and media;
- Reporting and project outcomes;
- Variations to the project.
